All applications for FACTS Tuition Assistance must be received before February 22, 2019. **APPLICATIONS CAN ONLY BE FILED ONLINE.**

The true cost of educating a child at St. Rose for the 2019-2020 school year amounts to \$7,200. We are trying to bring the deduction for multiple children closer to true cost based on the continuing rising costs.
